Question: Who should I make out the Purchase Order to?

Answer: Please make all purchase orders out to Horizon Discovery Limited since this will be the legal entity invoicing orders in Europe.

Question: I see that Horizon Discovery Limited is a U.K. entity. What currency will my invoices be in?

Answer: Our preferred currency is Pound sterling however, we also accept orders in Euro and US Dollars. Your invoice will be in the currency presented in the PO or credit card, and payment must be received as it was ordered.

Q. Can I pay by cheque instead?

A. Yes, although BACS, ACH or Wire are our preferred method of payment please contact accounts.receivable@horizondiscovery.com to discuss options.

Question: Can I still pay by credit card?

Answer: Absolutely!

Question: What impact will there be from a customs & duties perspective?

Answer: There should be minimal impact to our European customers, we are expecting a shorter shipment time overall.

Question: Will Horizon Discovery charge the appropriate taxes?

Answer: If applicable, please send your tax-exempt certificate to cs.dharmacon.eu@horizondiscovery.com. All other taxes will be calculated at time of invoicing using regional rates.

Question: Is my contract with "GE Healthcare Dharmacon, Inc." still valid?

Answer: Yes, of course! Current agreements and other contracts remain valid through the agreed upon term.

Question: Which of the products that I order are impacted by this name change?

Answer: The name change applies for any Dharmacon™ product, including CRISPR products, siRNA, shRNA and microRNA products, cDNAs and ORFs, transfection reagents, and custom synthesis products. Please continue to order non-Dharmacon GE products from the original entity.

Question: I have an order pending with Dharmacon. What happens to that order?

Answer: Any order placed with the original entity prior to February 19, 2018, will continue to process through the original legal entity name. If an order is placed with a lead time greater than 7 business days, past February 28th, we may contact you to make out a new Purchase Order to the correct legal entity. For any orders placed on or after February 19, 2018, just make sure to update your system's information to Horizon Discovery.

Question: I have an invoice from the original GE Healthcare Ltd entity. Who should I pay?

Answer: Please pay the entity listed on the invoice you have. But please update your system so future Dharmacon orders and payments will route to the new Horizon Discovery entity and remittance address.
